Happy Spring and thank you for voting! The good news is that precincts across Chester County experienced almost no concerning issues as was also the case across Pennsylvania. What has become a commonly accepted condition though is the serious matter of turnout. And although that turnout rate was comparatively higher to previous Presidential primaries, it continues to be concerning for its long term impact on our democracy. For many voters, it truly is a challenge to vote when they believe they have no candidate exciting enough to register their choice. That is and could be unfortunate. As we like to say in the League, "Democracy is not a Spectator Sport!"

<u>A note of interest for the League</u>: at both the local and the state levels, we experienced a high degree of inquiry regarding the topic of <u>"delegates</u>" with focus on their impact and influence in the outcome of elections. The notable difference in the governing rules and number of delegates between the two major political parties led to many discussions and many more unanswered questions. The delegate systems are complex at minimum and lead many to consider the value of their individual vote.

As the <u>Part 2</u> Election Cycle advances we can be assured that there will be additional topics introduced via the media that in the past would have been considered to be insignificant or un-noteworthy. But now today we are in full-fledged discovery mode.

One topic that has been quickly elevated for our review is the concept of: **What it means to be** <u>"Presidential</u>"? The results of a survey on this question might reveal a series of distinguishing characteristics for review, such as: Style? Manner? Tone? Dress? Face? Body type? Gender? Voice? You get the picture. What about those important features we call "issues"? Will they be lost in the battle? There is much talk about the bumpy road ahead for this **Part 2** phase. Voters want to hear candidates' views on issues and also candidates' solutions to current and future issues. They truly want to make a wise and informed decision.

It will be our job to maneuver those bumpy roads and to encourage our voters to hold strong and do the same. We owe it to ourselves and to the integrity of our democratic system! Buckle up!!

Budget Committee News

Dear Members,

As usual we are dealing with a very tight budget. More goes out than comes in so we continue to go into our savings to balance the budget. We do lots of volunteer work in the community. Much of our copying and printing is contributed as a gift in kind. Raising our membership dues was a help. Unfortunately, it is not enough to cover our financial needs.

We used our current paying membership of 61 full and 6 halves to estimate dues income and PMP expenses. Much work has been done this year to check on exactly how many members we have.

We have a shortfall of \$2316.50. We must decide how to cover it through fund raising, our Education Fund, or savings. For Fund Raising this past year we got \$195 from Boscov's and \$297.43 from our Signature Fund Raiser in September. Our goal this year is \$2500. We already have a Fundraiser letter out with our annual dues notice. We are also seeking information on corporate sponsorship. If you can help please let us know.

Our annual meeting will be held at noon, June 28 at The Elks Club in West Chester again. The cost is \$25. Our theme is the "Criminal Justice System" and our speaker is Judge Sprecher who authored <u>Justice or Just This</u>. More information is coming!

House and Senate Education Committees Hold Hearings on Every Student Succeeds Act

On April 12, PA Secretary of Education Pedro Rivera provided testimony to both House and Senate Education Committees on the implementation of the federal Every Student Succeeds Act (ESSA) in PA. The April hearing was the second joint Education Committee hearing concerning ESSA. The first, held on March 14, featured Lee Posey, Education Federal Affairs Counsel for the National Conference of State Legislatures, who provided an overview of Pennsylvania's responsibilities under the new federal law. HB 805, "Protecting Excellent Teachers" Passes House and Senate, Governor Vows to Veto

The bill would end seniority-based teacher layoffs ("last in, first out") and utilize only performance-based layoffs. Governor Wolf has stated he will veto the bill, citing numerous reasons, including its reliance on ineffective teacher evaluation system. On April 24, Governor Wolf allowed HB 1589, the Fiscal Code bill, to become law without his signature. The legislation implements the Basic Education Funding Commission's recommended funding formula for 2015-16 and provides reimbursement to districts for school construction projects (PlanCon). A New Strategy to Address Climate Change: Suing for Community Rights

"If recent headlines are any indication, environmental woes are mounting despite decades of attempts to reverse ecological devastation. A proliferation of environmental statutes, regulations and advocacy campaigns has fallen short of securing a clean and healthy environment for all.

Environmental issues, to be fair, are complex and difficult to remedy effectively. In one sense, they are a symptom of an underlying conflict of a continuously growing global economy pushing up against physical planetary boundaries. Endless pursuit of profit and economic growth has driven us to the brink of ecosystem collapse, whereby various interdependent components of the biosphere - oceans, atmosphere, wetlands, forests, etc.— begin to break down simultaneously. Trying to remedy one of these symptoms — passing a law to ban logging in old growth forests, for example — is almost pointless given the scale of the current ecological crisis.

Indeed, we've already tried this approach, creating laws addressing a plethora of environmental issues from endangered species and wilderness protection to air and water pollution. While there have been some improvements, the overall outcome is quite bleak. The United States ranks well below other wealthy nations in terms of environmental protection. A third of our plant and animal species are threatened with extinction, half of our wetlands and 90 percent of our old growth forests have been destroyed; and nearly half of our rivers, streams and lakes fail to meet the quality set by law.

These environmental indicators pointing to colossal ecological decline suggest, that modern environmental law has largely been a failure. The roots of our environmental and social problems are deeply systemic and thus require transformational change. A new system of political economy is needed. A new legal framework based on the ancient principle of the public trust doctrine. It is clear that environmental problems cannot be fixed using traditional legal or political tools. Deeper, structural changes are necessary – ones that address root causes of ecological ills rather than merely treat the symptoms.

The Public Trust Principle

Under this ancient legal concept, governments are trustees with a fiduciary obligation to safeguard natural resources on behalf of public beneficiaries, including present and future generations. The public trust is an inherent element of sovereignty, an unalienable right to sustaining natural resources essential to human survival. It provides a fiduciary frame that gives meaning to environmental law and invigorates it –unseating corruptible political discretion and installing in its place firm property-based obligations to manage natural resources for the long-term security of citizens."
