Pennsylvania voters have the historical opportunity to choose 3 new judges to the highest and oldest court in the Commonwealth. A situation that has not occurred for about 300+ years! The outcome in the November election will set the stage and tone for our state Supreme Court for a very long time. The role of the courts in upholding our Constitution and protecting our rights is a vital component to our democracy. Yet, through the election process, we perceive judges just like other elected officials. And in that process we can ignore the fundamental differences in their role. Judges are not supposed to be our representatives. "Judges make decisions based on the facts and the law, not according to their personal beliefs or popular will." So.....How does one "Judge a Judge"?

- Look at the ratings from the bar associations.
- Attend candidate forums.
- Read Voters Guide.
- Consider the following questions suggested by Pennsylvanians for Modern Courts:
- 1. What is the candidate's level of legal knowledge and experience?
- 2. Does the candidate have a good reputation for fairness and impartiality?
- 3. Does the candidate demonstrate a commitment to high ethical standards?
- 4. Has the candidate demonstrated a commitment to the community, including ongoing legal education, mentoring young lawyers, pro bono work and charitable activities?

Shoo-Mamas buys all its produce locally. I asked about the coffee used for my Cappuccino, it came from a roaster in West Chester. The food is simple and delicious. We would all recommend. It is located on the corner of Rtes. 926 and 202 in a small shopping center. We used a room in the back with ample tables and seating, and most important, quiet.

Discussed at the meeting were the issues faced by the small farmer and the organic small farmer. Overwhelmed by regulations some vendors have stopped selling certain organic foods. The growers also face regulations that are often a deterrent simply because of the cost of complying. Each of us present has agreed to research the various organizations: federal, state and local that impact small farmers. The time, date and location of the next month's meeting depends on when a speaker from Chester County Food Bank is available and will be announced in the Voter.

#### Commonwealth Court Rejects School Funding Lawsuit

The plaintiffs will take their case to the Supreme Court. "This is a legislative policy determination," Judge Dan Pellegrini wrote, referencing state Supreme Court rulings that eliminate any role for the courts in officiating school funding questions. In 1999, the School District of Philadelphia tried to sue the state for not providing it with enough funding. Commonwealth Court turned that lawsuit aside and the high court zapped the district's appeal.

Noting the current work of the Basic Education Funding Commission, Senate President Pro Tempore Joe Scarnati said he saw 'no reason' for the plaintiffs to pursue an appeal. The Commission's recommendations will be made public this summer, most like before the suit reaches the Supreme Court. #### Senator Pat Browne, co-chair of PA Basic Education Funding Commission injured in motorcycle accident

#### Keystone Exams Legislation: Update

No movement to report on any House or Senate bills introduced to date. However, there is encouraging news in a co-sponsorship memo recently circulated by Senator Dinniman, proposing legislation that would *'establish a moratorium on the use of the Keystone exams as a graduation requirement while the Basic Education Funding Commission continues its efforts to make recommendations to the General Assembly for a fair funding formula. The moratorium will continue while the General Assembly reviews the recommendations and designs a fair funding formula for enactment, then for a period of time afterwards so we can to ascertain the impact of that formula. Throughout the period that the moratorium is in place, the Department of Education will be responsible to continually review and ascertain any and all approaches for accountability so that it will be prepared to make recommendations on the different methodologies for accountability and assessment when the moratorium ends.'* 

The moratorium has bi-partisan support in the Senate and we will keep you posted on its path!

#### Senate Bill 1: Pension Reform

As promised, this session's '#1' priority, pension reform, has been introduced by Senator Corman and is currently in Senate Appropriations Committee. *The proposal does not reduce in any way or makes changes whatsoever to benefits already earned by existing employees or retirees.* 

Senate Bill 1 seeks to impact future costs and sustainability through the following:

#### New Member Benefits

- Defined Contribution for new employees: All new state and public school employees will be enrolled in a mandatory Defined Contribution Plan.
- Employers will be required to contribute the amount equal to the current DB normal cost of post Act 120 employees.
- For State Police, the employer contribution rate is 12.2%.
- Mandatory Retirement Security Plan: New employees will be required to contribute 3% of payroll into a cash balance plan. Employees will earn interest at the long term treasury rate capped at 4%.
- Members of the General Assembly, upon election and/or reelection, will be enrolled in the Defined Contribution Plan. The Defined Contribution plan provision will be consistent with state and public school employees.

### Current Member Benefits

- For all **future earnings**, contributions will be increased by 3% for PSERS and 2.5% for SERS to maintain Act 9 benefit levels. If the employee chooses not to increase their contribution to this level, the employee's prospective benefit rolls back to pre-Act 9 levels (2.0 multiplier and contribution of 6.25% for PSERS and 2.0 multiplier and contribution level of 5.0% for SERS).
- Anti-spiking Provision: Compensation for extra duty service included in each of the three highest years cannot exceed the average for the last five years of service. This provision currently applies to all post-Act 120 employees.
- Prospective Revenue-neutral Option 4: provides all future member contributions will be accessible upon retirement at an actuarially neutral rate beginning January 1, 2016 for SERS employees and July 1, 2016 for PSERS employees.
- Contribution Savings Provision: Every three years, the system will calculate the difference between actual and assumed returns. For every percentage that the system realized a return in excess of assumed returns during the calculation period, an employee's contribution, for those who chose the increased contribution option, will be reduced by ½ percentage point for the following three years. Those employees who did not choose the increased contribution level will not be eligible to have their employee contribution rate reduced.
- Optional Retirement Security Plan: employees will be eligible to contribute up to 3% of payroll into an optional cash balance plan.

### Additional Provisions:

- Public Pension Management and Asset Investment Review Commission: A commission of investment professionals and retirement advisors will be established to study, publish findings and make recommendations to the General Assembly and the Governor as to:
  - The performance of current investment strategies and procedures of both state retirement systems as to realize rates of return against established benchmarks and associated fees paid for active and passive management.
  - The costs and benefits of active vs passive investment strategies in relation to future investment activities of both state retirement systems.

- Alternative future investment strategies of both state retirement systems which will maximize future realized net of fees rates of returns with available assets.
- Extensive, detailed on-line publication of information about assets, returns, financial managers, all consultants, RFPs, and investment performance measured against benchmarks.
- The commission will include 3 members appointed by the Speaker of the House, the President Pro Tempore of the Senate and the Governor.
- The commission will submit its recommendations to the Governor and the General Assembly within 6 months of its first organizational meeting.

#### Funding Protection Mandate:

 Each member of PSERS and SERS, after the current employer compensation schedule meets the full actuarial amount, will have a contractual right to the annual required contribution made by the employer or by any other public entity.

Board membership/ qualifications:

- Membership: Both PSERS and SERS Board complement will be amended to add the Secretary of Banking and Securities.
- Training: Each member of the PSERS and SERS Board will be required to obtain 8 hours of mandatory training in investment strategies, actuarial cost analysis and retirement portfolio management on an annual basis.
- Independent Counsel: Legal counsel to both PSERS and SERS will serve independently from both the Governor's Office of Chief Counsel, the General Assembly and the Attorney General.

The drilling industry is trying to block even modest improvements to current regulations. In addition, industry groups like the Pennsylvania Independent Oil & Gas Association (PIOGA) don't want the public to have a voice in the process.

Our voices must be heard, demanding that DEP tighten regulations, including: Prohibiting operators from using open storage pits for drilling waste and other contaminants for both conventional and unconventional oil and gas wells.

- Requiring drillers to check for orphaned and abandoned wells near their drilling pads and paths.
- Implementing noise controls to protect the quality of life of people living near well pads.
- Restoring potable, clean water to those whose water supplies have been affected by drilling.
- Prohibiting wells near schools.

#### Dear Members,

Members always look at our budget and wonder how in the world we can operate and do all that we do. Our answer has always been lots of volunteer work and gifts in kind. There is so much to be done. *This year we are especially in need. So we will be asking for a vote to raise our annual dues to \$75. This is our first increase in six years. In that time the national and state portions of our dues have gone up so that we only keep \$14 out of \$65. We simply cannot carry on our work without this increase, and more fundraising. We truly appreciate our members' donations of time, effort, and gifts in kind!* 

Our signature fund raising event in September was successful, but we only broke even. We will have our second annual event this September 19<sup>th</sup>. Stayed tuned for more details!

When you pay your membership dues this year we encourage those who can to either voluntarily increase their dues payment or make out an extra check for a contribution made out to the LWVCC Education Fund. A contribution to the Ed Fund is tax deductible.

These are the changes of note:

- The new membership income has been adjusted to reflect our current membership of 88 full and 9 halves. This is down from last year. Our 15 honorary members do not pay.
- Our new budget reflects the dues increase to \$75.
- Again we have had to pull money out of the Ed Fund and savings to balance our budget.
- The costs of the Legislative Directories and the bookmarks are donated.
- Smart Voter will be replaced by VOTE411.org
- Printing "The Voter" every other month saves us money.
