
Ally explained to us what the Food Bank does, how many citizens are provided for by it, who the donors are and what its incredible facility does. It is amazing. The warehouse has both refrigeration and freezer. The kitchen has equipment any large scale cooking facility would die for. Sauces, vegetables, chilis and more are all prepared at the facility. The Food Bank enters the Chili Cook Off in West Chester annually. Storage space is almost unlimited.

While we were touring, one of the donors arrived with beautiful onions, lettuce and other vegetables. All organic. I could go on, but I encourage you to go and see for yourself.

When asked what we could do to help support the program, Ally responded that volunteers are needed, along with donations of 100% juice and meat products. Please help. This is a very worthy group.

In 1971 the U.S. Congress designated August 26, the anniversary of the passage of the 19th Amendment, as “Women’s Equality Day.”

1971 Joint Resolution of Congress Designating August 26 of each year as Women’s Equality Day

WHEREAS, the women of the United States have been treated as second-class citizens and have not been entitled the full rights and privileges, public or private, legal or institutional, which are available to male citizens of the United States; and

WHEREAS, the women of the United States have united to assure that these rights and privileges are available to all citizens equally regardless of sex; and

WHEREAS, the women of the United States have designated August 26, the anniversary date of the passage of the Nineteenth Amendment, as symbol of the continued fight for equal rights: and

WHEREAS, the women of United States are to be commended and supported in their organizations and activities,

NOW, THEREFORE, BE IT RESOLVED, the Senate and House of Representatives of the United States of America in Congress assembled, that August 26th of each year is designated as Women’s Equality Day, and the President is authorized and requested to issue a proclamation annually in commemoration of that day in 1920, on which the women of America were first given the right to vote, and that day in 1970, on which a nationwide demonstration for women’s rights took place.

US Congress and Senate pass versions of Elementary and Secondary Education Act Reauthorization

And now begins the work of sorting out the differences and coming to agreement.

On July 8, Congress passed the *Student Success Act* (218-213). Some highlights:

- States must test students in grades 3 through 8 in reading and math, and once in high school, plus science in certain grade spans, make the results public, and provide data to show how different subgroups of students, such as racial minorities, are doing relative to other students.
- Encourages states and districts to take a look at the number of tests they require and get rid of any assessments that are duplicative or low-quality.
- Parents could decide to opt their children out of tests without any penalties for their schools.
- States would be allowed to get out Adequate Yearly Progress (AYP) and the 2013-14 proficiency goals and develop their own accountability systems, and would have to consider overall school performance, and the performance of particular subgroups.
- States must set challenging academic standards in reading and math and the US Secretary of Education is prohibited from "coercing" a state to adopt a particular set of standards.
- States can, but are not required to, use federal teacher-quality funding to set up teacher evaluations. Eliminates No Child Left Behind's "highly qualified" teacher requirements and consolidates other teacher quality programs.
- Eliminates School Improvement Grant Program (federal funding directed at low-performing schools), allowing states to set aside 7 percent of their own Title I money for school improvement. States would have to intervene in Title I schools that are not performing well, but the bill does not dictate to them how to do so or how many schools to fix at a time.

- Merges programs aimed at migrant students, English-language learners, and neglected and delinquent children with a much larger Title I program for disadvantaged students. Districts could use the funds for any activity allowed under those programs. No money could be transferred out of Title I schools, but funds could go to other low-income schools.
- Eliminates or consolidates nearly 70 programs, some of which have not received federal funding in years.

On July 16, the Senate passed (81-17) the *Every Child Achieves Act*. Some highlights:

- States must test students in grades 3 through 8 in reading and math, and once in high school, plus science in certain grade spans, must make the results public, and provide data to show different subgroups of students, such as racial minorities, are doing relative to other students.
- Encourages states and districts to take a look at the number of tests they require and get rid of any assessments that are duplicative or low-quality.
- States would be allowed to get out of AYP and the 2013-14 proficiency goals and develop their own accountability systems. State test results would have to figure into these systems, but states could decide how much weight to give to them.
- States must set challenging academic standards in reading and math and the US Secretary of Education is prohibited from using federal funding to entice states to adopt a particular set of standards.
- States can, but are not required to, use federal funding to develop teacher evaluation systems. Eliminates the definition of "highly qualified teacher", letting states decide what constitutes teacher quality.
- Eliminates the School Improvement Grant program. School districts would be in charge of figuring out how to fix those schools, with help from states. Federal government would be prohibited from telling states or districts how to fix struggling schools.
- States can allow students in low-performing schools to transfer to a better-performing school.
- Changes the formula for distributing Title I dollars for disadvantaged kids, so that there is less of an emphasis on population, and more on poverty. Maintains separate programs for disadvantaged students, migrant kids, English-language learners, and other special populations. The bill would eliminate some federal programs, but it would also create a new preschool program for the first time in ESEA.

Protecting Natural Resources in Pennsylvania is a major task for Municipalities and the Citizens of Pennsylvania. The Pennsylvania Supreme Court has confirmed that Municipalities are empowered “to plan their development and to govern the same by zoning, subdivision and land development ordinances; planned residential development and other ordinances, by official maps, by reservation of certain land for future public purposes and by acquisition of such land.” (Pennsylvania Municipalities Planning Code – Act of 1968, P.L. 895, No 247 as reenacted and amended).

However, “We live in a state with very few rights for citizens about water and pipelines,” Senator Dinniman stated at a recent Public Meeting. “The (utility) companies can use eminent domain to do what it wants.” State and national conservation organizations and municipalities are working together to defend the right to protect the health, welfare, and safety of the citizens and encourage the public to organize and participate in supporting those efforts. Attend public hearings and support proposed Legislative Action.
