President's Message

Millions of Americans will head to the polls to vote in the primaries this season and the marathon of televised fanfare has begun. Deciphering truth vs. fiction, reality vs. unreality and envisioning the future relationship between new President and new Congress is quite a challenge!

State primary elections and party caucuses are a key part of the process to select the next President. They provide a crucial opportunity for voters to take control and to influence the process by selecting their top candidate. Voter turnout historically has been quite low, but there is now the thought, as evidenced already, that turnout for the 2016 primaries may change that dismal voter turnout history.

The League has its job to do with questions to answer and guidance to provide!

The most frequently asked question we hear is "*How Do I Learn About the Candidates*"? That is not a simple question to answer. We strongly encourage people to listen to speeches, interviews, commercials and ads. Research the candidates. Observe their behaviors, actions, reactions and interactions as they parade their campaigns through the various states.

<u>Candidate debates and forums are a core feature of U.S. politics</u> that help voters learn more about a candidate and his or her stance on key issues. Both the Republican and Democratic presidential candidates have been participating in a range of debates and forums since 2015. Additional debates and forums will occur throughout the primary and caucus season.

In addition to debates and forums, voters can learn about candidates through <u>VOTE411.org</u>, which includes upcoming events and other information provided directly from the candidates regarding where they stand on a variety of public policy issues.

Now, by the way, what about those **delegates**? And even better, those **"Super Delegates"!** Are you confused about the number, identity and impact of these influential participants in the nomination of a Presidential candidate? Take a look at the following explanation and see if it provides you with clarity:

"In some presidential elections, **superdelegates** can play a major role in determining the Democratic nominee. Unlike delegates, **superdelegates** are not bound to represent the popular vote of a region at the Democratic National Convention; they are free to support any candidate for the nomination. The Republican Party does not have **superdelegates**.

Superdelegates are not selected on the basis of party primaries and caucuses in each state. Instead, **superdelegate** standing is based on the status of current or former officeholders and party officials, including all Democratic members of Congress. **Superdelegate** is a term that arose in the 1970s.

In order for a candidate to win the party nomination for president, he or she must gain the majority of delegate votes. The purpose of **superdelegates** is for high-ranking Democrats to maintain some control over the nominating process. **Superdelegates** make up one-fifth of the delegates at the Democratic National Convention. So, 747 of the 5,083 delegates attending the 2016 Democratic National Convention can choose whichever candidate they prefer.

Out of 2,470 total delegates at the Republican National Convention in 2016, 437 are unpledged delegates who play the same role as **superdelegates**. Of the 437, 168 are members of the Republican National Committee."

Are you clear yet? I have to admit, I surely am not! But we can say for certain, the stage has been set and the show has begun. Participate and deliberate. And then, cast your vote!

Governor Wolf Signs Bill to Delay Use of Keystone Exams as Graduation Requirements

On February 3, Governor Wolf signed Senate Bill 880 into law. The law, now Act 1 of 2016, delays the graduation requirement associated with the Keystone Exams for two years until the 2018-19 school year. In addition to delaying the use of Keystone exams as a graduation requirement, the legislation also requires the Department of Education to investigate alternative methods for students to demonstrate proficiency for graduation beyond just the use of the Keystone Exams and present a report of its findings within six months to the majority and minority chairs of the House and Senate Education Committees. Senator Ryan Aument Assigned to Senate Education Committee

On January 19, Senator Ryan Aument (36th District representing northern Lancaster County) replaced former Senator (and current Delaware County Court of Common Pleas Judge) Dominic Pileggi on the Senate Education Committee. Senator Aument brings the experience of having served on the House Education Committee while a PA Representative.

Education Highlights from Governor Wolf's February 9th 2016-17 Budget Address

At his February 9th budget address, Governor Tom Wolf proposed a \$200 million increase to basic education funding, representing a 3.3% increase to the *assumed* \$377 million increase contained within the still incomplete 2015-2016 state budget. Highlights include:

Basic Education

\$200 million (3.28%) increase above the assumed \$377 million increase in 2015-16, for a total of \$6.3 billion to be distributed using the funding formula created by the Basic Education Funding Commission.

Special Education

• \$50 million (4.56%) increase in addition to the assumed \$50 million increase in 2015-16, for a total of \$1.146 billion.

Career and Technical Education (CTE)

 \$15 million in additional support for the establishment and expansion of high-quality CTE programs. Includes \$5 million for CTE equipment grants to support updating or purchasing new equipment used in the training of students.

Career Counselors

• \$8 million to help school districts offer college and career counseling in middle and high schools.

Assessment

• Funding for state and federal testing programs receives a 1.8% increase for a total of \$59.3 million.

Teacher Professional Development

• Level funded at \$7.46 million.

Early Childhood

- \$60 million (30.5%) increase for early childhood programs.
- Additional \$50 million for Pre-K Counts for a total of \$197.2 million.
- \$10 million more for a total of \$59.1 million for the Head Start Supplemental Assistance Program.

The budget also proposes the following accountability initiatives:

- Current School Performance Profile (SPP) system will be revised to take into account student growth, opportunities
 for advanced study, industry benchmarks, and student behaviors, like attendance, that impact school success and
 will show less reliance on test scores.
- PA Department of Education (PDE) will devote full-time resources and supports to address the needs of the state's
 persistently low-performing schools and establish an Office of School Improvement (OSI).
- Implements the recommendations of the Special Education Funding Commission by adjusting charter school
 reimbursements to better reflect actual costs of educating students with special needs. This change will be phased
 in over the next three years and result in more than \$180 million in savings to school districts.
- Implements funding changes for cyber charter schools that would save \$50 million annually for school districts across the state.
- Eliminates the state portion of the reimbursement to charter schools for employer retirement contribution costs (makes no changes to the requirement for school districts to pay 100% of these costs for charters).
- Includes a requirement for an annual reconciliation where charter and cyber charter schools will refund money to their sending school districts if the charter school's audited expenditures are less than its tuition revenue.

Finalized Clean Power Plan Outlines Key Ways to Stop Climate Change

The League Update, February 4, 2016 (Summary)

The Environmental Protection Agency (EPA) released the final version of the Clean Power Plan in 2015 – the first ever limits on carbon pollution from power plants. The plan takes the necessary steps to reduce this dangerous greenhouse gas, effectively protecting our children and future generations from the effects of climate change.

The EPA sought the public's involvement throughout the regulation process, which resulted in around the largest public engagement campaign the agency has ever conducted and over 4 million comments from the public, environmentalists, public health groups and industry officials regarding the proposal. The final rule reflects much of the feedback that the EPA received.

The Clean Power Plan is the biggest and most ambitious action the U.S. has ever taken to tackle climate change. A few key parts of the plan:

- Cuts Carbon Pollution from Power Plants.
- Provides State Flexibility to Meet State Goals.
- Invests in Renewable Energy.
- Protects Public Health.
- Paves the way for an International Climate Agreement.

U.S. Supreme Court Temporarily Halts Implementation of Clean Power Plan

The League Update, February 4, 2016 (Summary)

On February 9, 2016, the U.S. Supreme Court temporarily put the Obama Administration's Clean Power Plan on hold while challenges to the Plan will be heard. A lower appeals court is set to hear arguments in June and issue a ruling a few months later. That same court denied an identical request to stay implementation of the Plan that the Supreme Court granted.

Twenty-seven states and power industry officials are challenging the implementation of the Clean Power Plan calling it an overreach by the federal government. States have been tasked with formulating plans to meet the requirements laid out by the Environmental Protection Agency (EPA). Because of the decision by the Supreme Court, many states have already stopped their work.

Under the regulation that finalized the Clean Power Plan, state implementation plans are due to the EPA by September 2016. States must use the common sense building blocks defined in the Clean Power Plan to meet state goals outlined by EPA. The Supreme Courts' decision to stay the rule while arguments are being held threatens the timeline of implementation and jeopardizes the life-saving measures outlined in the Plan for generations to come. It will save lives, improve health, spur growth and protect the environment. (The League has been working to push the Obama Administration to develop and implement this historic regulation for years. We will continue to work to ensure that the Clean Power Plan is implemented properly in every state and that these life-saving measures are enacted.)

Wolf says PA will move forward on Clean Power Plan

The Wolf Administration says it will continue with plans to comply with new federal mandates to reduce the state's carbon emissions despite a decision by the U.S. Supreme Court which put a hold on Obama's landmark effort to combat climate change.

Pennsylvania is on target for coming up with its own implementation plan by the EPA's September deadline, and has held 14 listening sessions on the rules across the state. Governor Wolf's spokesman Jeff Sheridan says the Supreme Court's decision will not impact the state's ongoing efforts to comply with the CPP (Clean Power Plan). "Pennsylvania will continue planning and engagement with stakeholders on the Clean Power Plan, pending final decision of this issue by the Supreme Court," Sheridan wrote in an email to State Impact. "We will continue to closely monitor the ongoing legal process."

New Film, Forward Into Light, Highlights Inez Milholland

A group of California filmmakers hope to change the fact that most Americans have never heard her name. Inez Milholland is most famous for leading the 1913 Suffrage Parade on her horse, Gray Dawn, becoming an iconic figure for "Votes for Women". In 1916, at the request of the National Woman's Party, Inez traveled across the country, giving 50 speeches in 24 days through 9 Western states where women could vote. Fighting through exhaustion, anemia, dental infections and tonsillitis, she collapsed while at the podium at Blanchard Hall on October 23,1916. **Her last public sentence, "President Wilson, how long must women wait for liberty?"** She was taken to hospital where she died about a month later at the age of 30.
