Annual Meeting

Immigration is topic of League of Women Voters meeting

At their recent annual meeting, the League of Women Voters of Chester County (LWVCC) President, Susan Carty, said "these challenging times mean individuals need to make a commitment to stay on top of everything, and be vigilant to what is going on." Immigration is an area that is included in National LWV Policy Issues. "Promoting the reunification of immediate families, being responsible to those families facing political persecution or humanitarian crises," prompted the LWVCC to look at immigration.

"The need to protect our democracy means we need to become more informed voters," added Carty, calling on Sandy Schaal to introduce immigration lawyers, Anna Paciorek, Esq. and Pablo Quintanilla, associate attorney, to speak about "Current Issues Relating to Immigration."

Ms. Paciorek, a native of Warsaw, Poland who immigrated in 1988, is a graduate of Temple Law School, and adjunct professor at Temple. She was named a Top Immigration Lawyer in the 2018 Main Line Today listing of Top Lawyers. She worked with immigration issues and violence against women for 20 years, before starting Sweet and Paciorek with Lindsey Sweet.

Quintanilla, whose parents emigrated from El Salvador, is a graduate of Widener University Delaware Law School. Fluent in Spanish and English, he began working as a summer intern with Sweet & Paciorek in 2019.

The attorneys discussed three areas of their work: a brief update on what's happening at the border, Afghan refugees, and persons from Ukraine, before opening the floor to questions from League members.

"Immigration is always changing with each new administration that comes into office," said Paciorek. "President Biden has worked to get rid of the previous administration's immigration programs, which cited COVID as a reason for the poor treatment of immigrants. It's become political, and we're in a gray area. Changes were supposed to happen in mid-May until a judge stopped them," she added.

"Also, there is not the media coverage of unescorted minors crossing the border, and caravans of people escaping violence in their home countries, as there was during the previous administration," she said. "So people are not as aware of immigration issues."

"The courts are still clogged up, but applications have become more streamlined for asylum seekers. These immigrants, who come to the United States to live permanently, are mostly from El Salvador, Honduras and other Central American countries. Most are not professional

people; many don't even have a 6th grade education." Many of them work here in jobs such as landscaping and construction. They have family based green cards, employment based green cards, humanitarian green cards, lottery green cards. Some are longtime residents.

In response to a question, Paciorek said everyone coming into the U.S. goes to a COVID detention center. Many changes have been made following treatment by the previous administration, and conditions have improved because of COVID.

Another change is that local law enforcement does not automatically contact Immigration and Customs Enforcement (ICE) when they find immigrants in their communities. The Obama administration, and now the Biden administration, have created criteria for removing certain immigrants. For example, those who are terrorists or come from terrorist countries, and those with serious convictions, are not allowed in.

The second group of immigrants, Afghans who come to this country, are given temporary status, and want to settle here permanently. They are refugees, a legal term that enables an individual to receive some benefits, such as housing and employment. Some have families here, and some have worked with the U.S. government in Afghanistan.

"The third group of individuals coming to the United States are the Ukrainians, who have fled their country due to lack of safety and fear, and are given refugee status," explained Paciorek. "They do not want permanent status, but only seek asylum until they can return to their homes in Ukraine. There are two programs for them: receiving temporary protective status and obtaining permission to work, and working with non-related sponsors who want to help the Ukrainians. We're not seeing a lot of Ukrainians," said Paciorek, 'but we do see a lot of Afghans."

During the brief business portion of the meeting, Carty acknowledged the contributions of LWVCC members Mary Lou Dondero, Cathy Palmquist, Carole Mackrell, Deb Galleck, Meryle Rothman, Valerie Thomas and others.
