Criminal Justice Report

If you did not attend the annual meeting, you missed a very thought-provoking speaker! Celeste Trusty the Pennsylvania State Director for FAMM (Families Against Mandatory Minimums) has long been dedicated to helping transform Pennsylvania's criminal justice system. Her focus has been on coalition building to advance sentencing and prison reform and raising greater awareness about how families, communities and taxpayers are impacted by Pennsylvania's legal system.

One of her concerns is that prisoners are not given the opportunity to vote even if they are eligible. According to the Pennsylvania Voter Registration Application if you meet all other requirements, you may register and vote if:

You are in prison awaiting trial but have not been convicted.

You are in prison after being convicted of a misdemeanor only.

You have been released from prison or a halfway house after

completing your term of incarceration.

You are on probation or released on parole.

You are under house arrest. For more information you can go to www.vote.PA.gov.

All Voting is Local, Committee of Seventy, and Common Cause joined to do a study: Ballots for All: Holding Pennsylvania County Jails Accountable for Providing Ballot Access.

Currently, Pennsylvania county jails do not have a universal process for voter registration, voting by mail, or voter education. In 2021 These groups utilized Pennsylvania's right-toknow request statute to determine whether Pennsylvania county jails are ensruing each eligible voter has an equal opportunity to vote in each election. In March of 2021 public record requests went to 61 county jails in Pennsylvania. The survey coveredfour areas: policies, procedures, methods to register and apply for a mail-in-ballot, andvisitaion posicies and procedures. 75% of the counties responded. Thirteen counties (28%), Chester County included had brief policies with vague language related to voting and voter registration, and a detailed policy about voting procedures, and a detailed policy about visitation. Since the pandemic visitation at Chester County Prison is still somewhat restricted.

Our committee is pleased that Chester County Prison has a plan in place. We would like to know more. Would some of our information on voting and registration be useful? Can we help in any way?

Report on 2023 League of Women Voters Pennsylvania Convention

The convention was held at the Crown Plaza in Harrisburg from Friday June 16 to Sunday June 18. The main event on Friday was a tour of the state capitol building. We have a stunningly beautiful capitol building. The design is based on Renaissance European architecture with a large dash of Baroque décor and Americana paintings. There is a nod to the arts and crafts movement of the early 20th century with two acres of Mercer floor tiles. If you have not yet made a visit to the state capitol building, it is worth the trip to Harrisburg.

Later on, Friday afternoon, there were some breakout sessions scheduled including a discussion group on Juneteenth and Its Significance or the League and a Caucus on Special Education Funding. Later in the evening was a Welcome Reception co-hosted by the National Council of Negro Women-PA.

After breakfast on Saturday morning were three more breakout groups. A discussion on Growing Diverse Membership, and two Caucuses. One called "Climate Crisis, Next Steps" and the other on a proposed study of the LWVPA Legislature Position.

At 9:30 the convention was convened, and we all learned how to use an electronic voting system. Once everyone got the hang of it, it worked quite well. The first vote was for the adoption of the rules for the convention. After the president's address we received the treasurer's report and voted on the budget for the fiscal year 24-25. We voted on amendments to the bylaws. Some produced heated discussion while others passed very quickly. There was a professional who advised on Robert's Rules of Order when things seemed to be getting confused. The keynote address was presented by Kandida Kenner of the New Pennsylvania Project which is working to register voters of color. After her speech, we looked into the future and then voted on the upcoming board. During the dinner Saturday evening, we heard the executive director's report and the awards presentation.

Sunday morning there were three more breakout rooms. There were two discussion groups: LWVPA board structure taskforce and navigating nonpartisanship during a hyper-partisan time. There were also two partner presentations: Meet Fair Districts PA and Meet PA Youth Vote. At 9:30 we all met again to vote on adjustments to the wording of LWVPA's position on Natural Resources and Social Policy. The information needed to be clarified and updated. When the voting was completed, several League chapters provided suggestions for guidance to the board. It was the end of a stimulating if tiring convention.
