Last day for County Board of Elections to receive voted mail-in and civilian absentee ballots (must be received by 8:00 P.M.) **May 20**

MUNICIPAL PRIMARY **May 20**

First day to **REGISTER** after primary **May 21**

Last day for County Board of Elections to receive voted military and overseas absentee ballots (submitted for delivery no later than 11:59 P.M. on May 19) **May 27**

Last day to **REGISTER** before the NOVEMBER election **October 20**

Last day to apply for a mail-in or civilian absentee ballot **October 28**

Last day for County Board of Elections to receive voted mail-in and civilian absentee ballots (must be received by 8:00 P.M.) **November 4**

MUNICIPAL ELECTION **November 4**

First day to **REGISTER** after election **November 5**

Last day for County Board of Elections to receive voted military and overseas absentee ballots (submitted for delivery no later than 11:59 P.M. on November 3) **November 12**

You must re-register to vote if you changed your name, address, party affiliation or have not voted in 5 years.

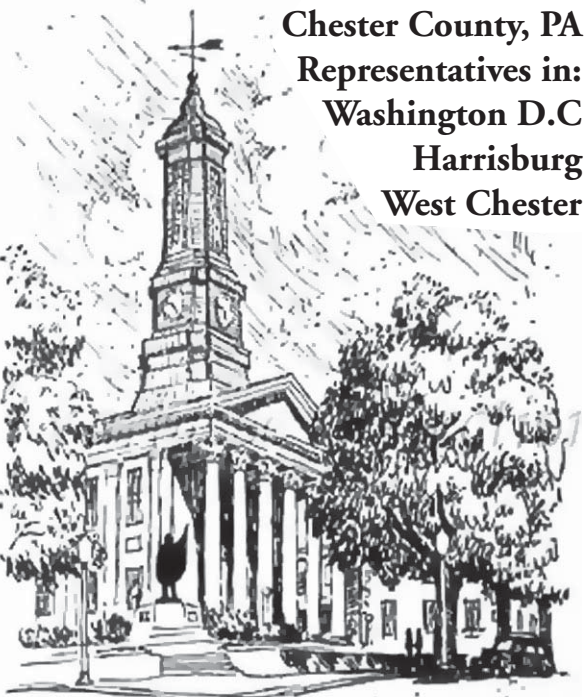
